 - (1) THE TEXT ON THE BACK SIDE OF THE VIOLATOR COPY OF THE UNIFORM TICKET MAY BE REPLACED WITH THE TEXT PROVIDED IN **APPENDIX A**.
 - (2) THE TEXT ON THE BACK SIDE OF THE COURT COMMUNICATION COPY OF THE UNIFORM TICKET MAY BE REPLACED WITH THE TEXT PROVIDED IN **APPENDIX B**, OR IF THE AGENCY WISHES TO ELIMINATE THE TOP BOX, "AVOID MULTIPLE COURT APPEARANCES," THE TEXT ON THE BACK SIDE OF THE COURT COMMUNICATION COPY MAY BE REPLACED WITH THE TEXT IN **APPENDIX C**.

(5) NO ADDITIONAL MODIFICATIONS TO THE PRINTING OF THE UNIFORM TICKET ARE AUTHORIZED.
