notify the parties or their counsel that he/she is unable to accept the appointment. By filing an appearance, the  
Mediator represents that he/she is in compliance with the qualifications/requirements set forth in Rule 14.5  
necessary to serve as a mediator.

That the Mediator's AOIC Report shall be submitted to the Court and to the parties' attorney prior to the  
status date.

That Memorandum of Agreements arising out of this Court Ordered Mediation shall only be submitted to the parties' attorney (or parties if no attorney).
