Message from the Circuit Clerk

When I served on the Kane County Board for District 2, I had the opportunity to serve on several committees. Those committees included, Energy and Environment, Executive, Development, Finance, Judicial and Public Safety, Labor Management, Human Services, Riverboat Commission and co-Chair Jobs. I was Chair of CDBG (Community Development Block Grants), Development, and the Foreclosure Taskforce. This was just the first four years in office. The next four years were challenging for the county. But this service gave me insights into the budget and the budget process. When serving on those county committees, I met with the directors of departments and other office holders throughout the county. I learned how Kane County is structured and what is required of our elected officials throughout the county. I was able to determine the difference between low and high performing offices. With my previous public service experience, I believed I could contribute more to the county. This supported my decision to run for the office of Kane County Circuit Clerk.



In the next 18 months, I listened to people that weren't able to have their voices heard. Many complained about the lack of leadership at the Circuit Clerk's office. Many judges, attorneys, employees, expressed the need for

improvement in this area. It appeared that the office was in a holding pattern and needed new vision and leadership in order to better serve Kane County. The judicial system consists of the Courts, States Attorney's Office, Sheriff, IT and the Circuit Clerk's Office. It has been a pleasure working alongside my colleagues in the judicial system. In reality the judicial system would not be able to operate without the clerks. They maintain all of the court records and conduct daily functions of the office. Based on extensive feedback, I wanted to upgrade our case management system and update the office structure. In other words, we already paid for the case management system and it should function correctly. I am pleased to announce that finally we have addressed this huge hurdle. This was not an easy fix but required cooperation and hard work from the Kane County IT Department, Tyler (our case management system), and the Circuit Clerk's staff. I look forward to accomplishing many more goals in the next year, and with the help of the staff I hope to make the Circuit Clerk's office something the people of Kane County can be proud of.

The main location is the old Montgomery Ward's building on S. Randall Rd., in St. Charles. This location houses the criminal, civil, accounting, and records teams. 




ORGANIZATIONAL CHART

August 9 2021



The **Kane County Circuit Clerk's Office** in conjunction with the **County Clerk's Office** are offering another way for individuals with outstanding fees and fines to resolve them.

The new Circuit Clerk's drop box is located in front of the office at 540 S. Randall Road, St. Charles.

Similar to the Treasurer's Office property tax drop box and the ballot box that the County Clerk's Office provides for voting, the Circuit Clerk's Office at 540 S. Randall Road in St. Charles now offers a drop box for court-ordered payments.

"Officials at the Circuit Clerk's Office realize the struggles that the public have been experiencing during this pandemic," Kane County Circuit Clerk Theresa Barreiro said. "We are doing our part to assist people who can't get to our office during normal business hours due to job or transportation barriers."

Barreiro said the 16th Circuit Court's move to Zoom courtroom meetings is one of the reasons she wanted to offer the drop-box payment option.

"Previously, when an individual went to court and had an outstanding balance, he or she could take care of it in person," she said. "Now, that person has to either pay online or make an extra trip to the Circuit Clerk's Office to clear their balance. This drop box just makes it a little easier and more convenient for folks to do that."

Barreiro emphasized that the drop box is secure, tamper-proof and monitored by security cameras.

The Circuit Clerk's Office asks that no cash be placed into the drop box. Residents are invited to drop off their payment, either during office hours or after.




Expungement Clinics

In September the Circuit Clerk and her executive staff in partnership with States Attorney Jamie Mosser, Prairie State Legal and several local legal volunteers, held three Expungement Clinics. These were held throughout the county for Kane County residents to be able to attend.

The Expungement/Sealing process can be complicated and can take approximately 75 days by statute from start to end. This process can be overwhelming to have even a minor offense removed. The clinics provided information on the process with a brief presentation, and then the legal representatives volunteered their time to help people with paperwork followed by Q & A. The Circuit Clerk's office filed various petitions from these clinics getting people on their way with the process to get court orders approving their files be expunged and/or sealed.
