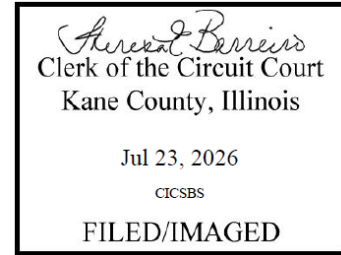

IN THE MATTER OF
AMENDING GENERAL ORDER 24-11
JUDICIAL ASSIGNMENTS
AND COURTROOM SCHEDULES



WHEREAS, subject to the overall authority of the Illinois Supreme Court and pursuant to Illinois Supreme Court Rule 21, the chief judge having authority to determine courtroom scheduling;

WHEREAS, Kane County Forest Preserve cases shall be heard in the Kane Branch Court (KBC) on the first Wednesday of each month;

IT IS HEREBY ORDERED: That General Order 24-11 entered on March 13, 2024 is hereby amended as follows:
