**ASSIGNMENT OF FELONY MATTERS**

All Kane County felony cases, with the exception of Felony Domestic Violence matters, Class X, Class I, Class M, Involuntary Manslaughter, Reckless Homicide pursuant to § 720 ILCS 5/9-3, and Felony Aggravated DUIs<sup>1</sup> shall be assigned to Courtroom 123 for pre-arraignment. With the exception of Aggravated DUI's and matters which are assigned to the Felony Domestic Violence court in room 217<sup>2</sup>, all Class X, Class I, Involuntary Manslaughter and Reckless Homicide pursuant to § 720 ILCS 5/9-3 and M felony matters shall be assigned by the Circuit Clerk to a trial courtroom in 305, 311,313 or 319 at the time of filing.

When a defendant is charged with multiple offenses within the same charging document, the courtroom assignment will be based upon the highest class felony. Where there are two or more such felonies of the same class which would result in assignments to multiple courtrooms involving 123, 203, 209, 211 or 217, the matter shall be assigned to courtroom 123 for pre-arraignment. Unless for good cause shown, no case shall remain in courtroom 123 for a period to exceed 90 days.

Upon filing of an indictment or information, or by Motion of either party or the court, the matters originally set in courtroom 123 shall be assigned by the Circuit Clerk's automated system to a trial judge in either courtroom 305, 311, 313, or 319 for arraignment and all pre-trial, trial and post-trial proceedings.

**ASSIGNMENT OF AGGRAVATED DRIVING UNDER THE INFLUENCE CASES**

Class X, I and II, III and IV Aggregated Felony DUI cases are assigned to Courtroom 217 at the time of filing for all arraignment, pre-trial, trial and post-trial proceedings.

**ASSIGNMENT OF JURY CASES IN MATTERS INVOLVING MISDEMEANOR AND ORDINANCE VIOLATION**

If a defendant requests a jury involving either a misdemeanor or an ordinance violation which was originally set in one of the Branch Courts, said matter shall be transferred and continued to courtroom 217 at the Kane County Judicial Center, for the purpose of the Misdemeanor Jury Trial Coordinator assigning the matter to a courtroom for jury trial. All discovery must be completed and all pretrial motions resolved and jury instructions must be prepared (this includes motions to quash and motions *in limine*) prior to a Jury Demand transfer to courtroom 217. Once all preliminary matters have been completed the matter shall be set in courtroom 217 on any Thursday at 1:30 p.m., giving enough time for witnesses to be served with subpoenas. The Misdemeanor Jury Trial Coordinator will assign the matter to an available judge for jury trial to be heard the following Monday or Tuesday, but due to scheduling at the Judicial Center, the actual trial date cannot be known until Monday morning. If the defendant later waives jury, the file will be sent to the original court of origin for bench trial setting. If the defendant fails

to appear for the jury trial pretrial or fails to appear for the jury trial, a warrant may be issued with direction that it should be returned to the branch court of origin.


