### GO TO THE 16<sup>TH</sup> JUDICIAL CIRCUIT WEBSITE

Open the web browser (examples: Safari, Chrome, Internet Explorer, Edge, Mozilla) on your smartphone and enter **kanecourt.org** in the URL address bar. Click on **LIVESTREAMING** on the **middle** of the page.

### CLICK "JOIN WITH VIDEO"
